Surveyor's Comments:

History:

North 110 feet of lot 12, Lewis & Brehler's Addition to the City of Mount Clemens
Prior to citywide renumbering in 1896, the postal address of this property was 35 Church
Developers Lewis & Brehler sold this lot on their new subdivision to Martin McClenathan for
\$200 in May 1884. McClenathan sold the property less than 2 years later to Henry Thede for
\$600. It is unknown whether McClenathan or Thede built the house on the lot, but the house is
shown on the 1897 Sanborn fire insurance map of Mount Clemens and the prior address of 35
Church is listed in the 1896-97 Mount Clemens city directory. The house is presumed to have

been built sometime between May 1884 and 1896.

George Dalby was the resident at the property according to the 1900 federal census; he purchased the property from Henry Thede in 1902 and owned it until September 1919. By the time that the 1921 Sanborn fire insurance map was drawn, a small store building had been added to the northeast corner of the house, facing Church Street. The May 1930 Sanborn map shows that the store building had been expanded to the west, and the April 1945 Sanborn map shows the store building as it is currently configured in 2018.

Victor and Rebecca Fink purchased the property in January 1924, and operated Fink's Grocery there. Fink is listed as the proprietor of a grocery store in the 1930 and 1940 federal censuses. The Finks sold the property on land contract in 1945.
